8. INVITED ADDRESSES, PRESENTATIONS OR ACKNOWLEDGEMENTS

COUNCILLOR MCKENZIE attended the Community Achievement Awards Australia on Friday 1 December 2023. He was over the moon that two local organisations made the finals, being PavFab, Yarram and A Better Life for Foster Kids Inc, Sale.

PavFab, owned by Sharee and Paul Wilson, are an engineering and fabrication business that started in 2015 and were finalists in the category of Business Achievement Award. He described their unwavering dedication to empowering first nations people and rehabilitating individuals by providing employment and training.

Councillor McKenzie noted that by actively collaborating with local councils, government bodies, and indigenous support organisations, they are catalysing transformation in the region. Their charitable spirit shines through donations and support for school programs, and fostering inclusivity and cultural awareness.

Councillor McKenzie noted that when he caught up with Sharee and Paul to congratulate them on being finalists, they advised that next year they aim to employ a further four first nations people, which is testament to their valued proposition of supporting and providing a better future for those most vulnerable. Although they unfortunately didn't win the final

award, they are winners to the people of Wellington and Yarram. He wished PavFab all the best for the future.

Councillor McKenize also acknowledged Heather Baird from A Better Lift for Foster Kids – a well known not-for-profit organisation she began in 2014. He noted that Heather was a foster child herself, and knows only too well the effect this has on our youth.

When Councillor McKenzie caught up with Heather, he asked her insights on foster care and her reply was heartbreaking. The rate of foster children in the Victorian system is around 9 percent, however in Wellington it is at 14 percent, and that Wellington is now experiencing the seventh generation of families reliant of welfare. When we consider that Wellington is the fourth worst council for domestic violence in the community, we certainly have work to do. On a positive note, A Better Life for Foster Kids received the Regional Service Award. He sent a huge congratulations to Heather and her team of volunteers from all within Council.

Councillor McKenzie expressed his final congratulations to both organisations for their dedication to community service, and support to the most vulnerable. He also made special mention of the Rochester Community House who won the award for Connecting Communities and the People Award following a challenging time.

COUNCILLOR BYE acknowledged that the community had to unfortunately endure floods again with an extreme amount of rain. Councillor Bye acknowledged the volunteers within the community, the SES and the emergency services for the great work they do. He also acknowledged the Council team that go beyond expectations by attending to those in the middle of the night and making sure residents are safe. Councillor Bye acknowledged the community's resilience, having come out of this event quite well due to the volunteers that ensure everyone's safety. He thanked the team on a job well done.

FURTHER GALLERY COMMENTS -

CHRISTINE TIMMERMAN, ALBERTON – Addressed Council regarding the Gelliondale wind farm and applicable environmental legislation. COUNCILLOR BYE noted that the Councillors have access to a paper Christine had previously submitted. Christine referred to various sections of her paper with relevance to the Gelliondale windfarm. She noted a number of her concerns regarding the location of infrastructure development within Gelliondale and the impact on the Ramsar wetlands.

GRAEME JAMES, GELLIONDALE – Addressed Council regarding proposed wind turbine construction in Gelliondale and concerns regarding recent flooding in the area. He further noted his concerns around the background noise predictions.

THELMA KEELY, STRATFORD – Addressed Council regarding her concerns relating to the replacement of the current wheelie bins within Wellington Shire. She queried why her perfectly good bins need to be replaced and would like to know how many are being taken away, how many are being replaced and what Council is going to do with the wheelie bins. She thinks it is a complete waste of money.

Thelma further raised there was a horrific attack of an alpaca across the road from her by two dogs that were running around in Stratford. She reviewed video footage of the attack and the aftermath, including the arrival of police. She would like Council to be aware of the impact of the attack and asked what Council are doing about this, noting it took the ranger two hours to respond to this incident due to other priorities.
