COUNCILLOR BYE made some closing remarks at the end of his Mayoral term. He thanked CEO David Morcom for his assistance over the last year and the Councillors for their support.

COUNCILLOR BYE attended the East Sale RAAF Base on Thursday 2 November 2023 to celebrate the laying of the Queen's Colours and acknowledged the two training schools at East Sale RAAF Base; the Air Mission Training School and No.1 Flying Training School. He explained that all squadrons have a unique known as their 'colours'. Councillor Bye noted that the colours are replaced ever 25 years, by written request to Her Majesty The Queen, as it was at the time. The Queen would then commission new colours to be made. After a ceremony in England, the colours are then sent out to where they are replacing the old colours.
