PUBLIC QUESTIONS AND COMMENTS FROM THE GALLERY

Rod Doke, Cobains: Is aware of the problems the petitioners have with the feedlot. He was wondering, had there been a proposal put forward for that particular feedlot to the Shire?

Councillor Bye confirmed that the Council Meeting isn't a forum for questions and answers. The Chief Executive Officer directed Mr Doke to the General Manager Development who can provide some updates.

Mr Doke noted that the Victorian planning scheme specifically mentions that a feedlot must not be within 300 metres of someone else's house. There are houses within 25 meters, 35 meters. There is total disregard of that element of the code.

The other thing is that there are certain number of elements that need to be addressed in the proposal to the Shire. He does not think that any of the conditions in the code have been looked at. Another condition is that a feedlot must be 200 meters from any road, but this feedlot is situated on Bengworden Road for everyone to see.

There has been a study of the waterways. Failure to mitigate improper use surrounding the catchments has been identified as an issue. If these feedlots are allowed to continue, Mr Doke thinks the Shire is complicit in that problem as well as forgetting about their rate payers.

Geoff Mynard, Cobains, Head Petitioner: The other concern is the double standards by the EPA. Mr Mynard raised that he has been required to install an environmental septic system because of the impact to the ground level water which is high in that area. Then fifty meters away, there is a pit into the ground water level, to hold manure and run off which is putting the waste straight into the water table. When Mr Mynard has rung after rain, and complained to the EPA, no one comes out, no one does anything.

Mr Mynard referenced the other issue nearby with more feedlots noting that runoff from the paddock is contaminating a dam and running straight into the Gippsland lakes. Mr Maynard raised that it needs to be looked at a further level.

Councillor Bye noted that Council takes these matters seriously. Council has written to the head petitioner on 11 December 2023 and are waiting on advice from government departments. Councillor Bye advised that further contact will be made in the New Year.

COUNCILLOR TATTERSON met with Minister for Roads and Road Safety, Melissa Horne MP at the invitation of the Department of Transport and Planning. The meeting provided the opportunity for some workshopping. Key SEATS (South East Australian Transport Strategy) priorities came through including the Mitchell River bridge duplication at Bairnsdale, the Sale alternate truck route, delays with the Traralgon Bypass and issues with lower speed limits west of Longwarry. One of the other key issues was the landslips on Traralgon-Yarram Road.

COUNCILLOR TATTERSON acknowledged participating in the recent Sale Golf Club Sporting Legends Pro Am with Councillor McKenzie. He congratulated the Middle of Everywhere staff in supporting these successful events across Maffra, Sale and Yarram.

COUNCILLOR RIPPER attended the Keith Hamilton Toy Run on 9 December 2023 with Councillor Bye. She acknowledged the Police presence on the day and their positive communication with young people on the day.

COUNCILLOR RIPPER acknowledged the twenty-three Crossing Supervisors that keep families safe across Wellington Shire. She further thanked the Council staff for their work throughout the year.

COUNCILLOR MCKENZIE acknowledged the 30th Anniversary of the Loch Sport public hall on Saturday 9 December. It was a pleasure to celebrate this occasion with Councillor Stephens and Danny O'Brien MP. The celebration was well attended, will attendees signing a time capsule that was then buried to be opened on the fiftieth anniversary. A tree was planted by Peter McMahon, whose parents built the hall thirty years ago. At the recent Neighbourhood House, AGM representatives of the Loch Sport public hall received the award for Community Resilience 2023 presented by Toni Halloran-Lavelle to Eleanor Speed, Ren Renehan and Rachel Mulder. The award was a result of the hard work of creating the Loch Sport Resilience Guide map. A great week of celebration for the community of Loch Sport.

COUNCILLOR MCKENZIE acknowledged the transformational changes in Port Albert. Three years ago community leaders met with Council management and Councillors Maher and McKenzie to brainstorm ideas to transform Port Albert. Three years on the changes have been many and varied. He noted many upgrades Port Albert has received. Port Albert is now ready for the next generational change, being the offshore wind development. He sends his sincere thanks to the Built Environment team and his fellow Councillors for supporting these initiatives.
