## 8. INVITED ADDRESSES, PRESENTATIONS OR ACKNOWLEDGEMENTS

COUNCILLOR MCKENZIE acknowledged the town of Seaspray as a finalist in the 2024 Tiny Towns and Cities “Keeping Victoria Beautiful” in the category of Heritage and Culture. Seaspray has been recognised for the twelve historical signs along the town’s historic foreshore showcasing Seaspray’s history. The signs offer glimpses into the town’s past, highlighting and celebrating the town’s socio and cultural history including beachside fashions, early streetscapes, the General Store’s beginning and the supply of fresh bread and milk to campers in the 1920s and 1930’s. This project was the brainchild of Kaylene Wheeler, President of the Seaspray Ratepayers Association, and with special mention of Sue Kennedy for all her hours of research into the history and storytelling of Seaspray by pictures and the wonderful financial support of Esso. Her dream became a reality.

Seaspray were up against two other historical and significant heritage finalists, both in Beechworth - The Golden Horseshoe Festival and Beechworth Court House. The winners will be announced on October 28 and on behalf of the Wellington community, Councillor McKenzie wished Seaspray all the best and hopes they are awarded the 2024 Tiny Towns Heritage and Cultural Trophy.

COUNCILLOR CROSSLEY congratulated and acknowledged the 2024 John Leslie Art Prize, our richest and most loved landscape painting prize. The community was well engaged with 200+ people attending the gallery opening for the exhibition on 6 September. It was a packed event. The winner, Peter Gardiner – with his large oil, wax and glitter painting ‘Elephant’ depicting storm destruction and damage in the forest – acknowledged in his acceptance speech that it is an important and well-loved exhibition for artists across Australia. The exhibition was beautifully presented which was remarked upon by the artists who were very pleased to be part of it. The “Best Gippsland Work” winner was Linda Gibbs, whose recent work “Aurora Over Corner Inlet” is a beautiful romantic landscape piece.

Not only are these events loved by the arts community, but Councillor Crossley commented that the restaurants and accommodation venues are “packed to the gunnels” and the feedback is that these events are a cultural and economic stimulus to the town. Councillor Crossley encouraged people to visit the exhibition which is bursting with new exhibits. It is the first time the Borun & Tuk exhibition has been in the larger space at the gallery as well as the new youth exhibition space.

MAYOR BYE acknowledged the Municipal Association Victoria (MAV) Annual Awards night which he attended and Councillor Crossley who received an MAV Councillor Service Award for her 15 years of service as a councillor, a big achievement. Mayor Bye thanked and congratulated Councillor Crossley for her years of service, and presented her with the Councillor Service Award and a special pin imprinted with 15 years of service to local government.

COUNCILLOR MAHER acknowledged Mayor Bye who was also recognised with a Mayor Emeritus Award for his leadership and service to the Wellington Shire Council. Councillor Maher passed on her congratulations to Mayor Bye on behalf of all sitting there today.

MAYOR BYE also acknowledged the Gippsland New Energy Conference (GNEC) held in the first week of September in Traralgon and hosted by Latrobe City Council. It had been hosted in Wellington Shire at the Wedge for the first two years. It was quite pleasing to see the acknowledgement that Wellington Shire received for adopting and bringing this new energy to Gippsland and being at the forefront of this new renewable energy to bring future jobs to our area. There were about 800 delegates, 350 students and 150 different speakers, keen to see that renewable energy in our region does succeed and does keep going. We were lucky to have the Federal Minister, the Hon. Chris Bowen MP, fly down to do a couple of announcements, including attending the launch of the Gippsland Offshore Wind Alliance.

Councillor Bye congratulated the hard working team at the Gippsland Climate Change Network for delivering such a great conference which was well received by all. With the growing numbers, extra room was needed, so it was fantastic to have the larger venue hosted by Latrobe to make it a success. We look forward to next year's conference which will be even bigger and better again as we continue to build each year.
