3. CHIEF EXECUTIVE OFFICER

3.1. COUNCILLORS TO TAKE THE OATH OR AFFIRMATION OF OFFICE

ACTION OFFICER: CHIEF EXECUTIVE OFFICER

PURPOSE

In order to undertake the role of a Councillor, all persons elected as councillors must take the oath or affirmation of office.

BACKGROUND

In accordance with section 30 of the *Local Government Act 2020*, a person elected to be a councillor is not capable of acting as a councillor until the person has taken the oath or affirmation of office in the manner prescribed by regulation 5 of the *Local Government (Governance and Integrity) Regulations 2020*.

In taking the oath or affirmation of office, councillors-elect must have read the Model Councillor Code of Conduct and make a declaration stating that they will abide by the Councillor Code of Conduct and uphold the standards set out in the Councillor Code of Conduct.

ACTION OFFICER: CHIEF EXECUTIVE OFFICER

PURPOSE

For Council to elect a Councillor to be Mayor at a meeting that is open to the public in accordance with the *Local Government Act 2020*.

PUBLIC QUESTIONS AND COMMENTS FROM THE GALLERY NIL

The Chair called for nominations for Mayor.

COUNCILLOR TATTERSON was nominated by Councillor Ripper. COUNCILLOR TATTERSON accepted the nomination.

COUNCILLOR ROSSETTI was nominated by Councillor Stephens. COUNCILLOR ROSSETTI accepted the nomination.

There were no further nominations.

The Chair called for a show of hands for the nominated candidates:

COUNCILLOR TATTERSON – Councillor Ripper – 1 vote.

COUNCILLOR ROSSETTI – Councillors Tatterson, Foat, Rossetti, Madeley, Wells, Bannerman, Lowe and Stephens – 8 votes.

The Chair announced an absolute majority vote in support of Councillor Rossetti for the role of Mayor.

The Chair formally declared COUNCILLOR ROSSETTI as Mayor of Wellington Shire Council and congratulated Councillor Rossetti on his election.

Councillor Rossetti assumed the role of Mayor and Chair.

Councillor Rossetti extended a thank you to his fellow councillors for supporting his nomination and thanked Councillor Tatterson for putting his hand up as well.

Councillor Rossetti acknowledged the former Council and acknowledged the work they have done as well as the preceding Councils as 'we do stand on their shoulders'. The work done before makes the current Council's job a little easier to achieve outcomes for the community. Councillor Rossetti spoke of how fortunate the Wellington Shire has been with a number of very stable councils in a very long row which cannot be said of many councils around the state. The coming together of a diverse group is exciting. Councillor Rossetti commented that this is one of the best Councils the shire has had with a group of people with many different views who come from many different angles and represent many different demographics and different ideas.

Councillor Rossetti has already observed the work that has been done through the election process and through the workshops today and everyone works well together. No doubt there will be different perspectives which is very healthy. There will be a lot of fresh ideas with the corporate knowledge to be able to support the basics underneath.

Councillor Rossetti expressed that he is looking forward to the next four years and the next year as Mayor and appreciates the support he has been given.

PURPOSE

For Council to elect a Councillor to be Deputy Mayor at a meeting that is open to the public in accordance with the *Local Government Act 2020*.
