8. INVITED ADDRESSES, PRESENTATIONS OR ACKNOWLEDGEMENTS

COUNCILLOR MADELEY attended the launch of the 'Live for Life' program in the Wellington Shire on Friday morning, a youth mental health and suicide prevention initiative which is now active in the local high schools aiming to equip all year 8 students with the knowledge and skills to support their mental health and that of their peers. This program would not be possible without the support of the John Leslie Foundation and stakeholders within the community. Councillor Madeley thanked the Wellington Shire Council staff who worked to make this program a reality.

COUNCILLOR MADELEY also acknowledged her attendance with Mayor Rossetti at the National Reconciliation Week service held at the Ramahyuck District Aboriginal Corporation in Sale. It provided an opportunity for reflection on shared history, emphasising the importance of unity, understanding and truth telling. It was an emotional service that reinforced the need for a commitment to reconciliation and the ongoing journey toward a more inclusive community. The theme for reconciliation week 2025 was *Bridging now to next*, reflecting the connection between past, present and future. Councillor Madeley thanked Wellington Shire Council staff in attendance to support this important week.

COUNCILLOR RIPPER acknowledged and congratulated some individuals and businesses on their recent achievements for the Gippsland region which highlights the strength, talent and dedication in the community, with Madelaine Breakspear from Sale winning the award for Community Coach of the Year at the Victorian Sport Awards. Madelaine's leadership with the Sale United women's football club has delivered multiple wins and her contribution on and off the field makes a real difference to the lives of young athletes across Gippsland.

COUNCILLOR RIPPER also noted the success of the Tinamba Hotel in being awarded the 2025 Australian Hotel Association Victoria awards for excellence as "Best Pub/Restaurant, Regional" and Quinn Jacobs was named Apprentice of the Year. The Star Hotel in Sale won the regional category for the best chicken parmigiana. Such awards prove, once again, that local venues are delivering 'top notch' dining experiences which emphasise the importance of local jobs and businesses.

COUNCILLOR WELLS acknowledged the Wellington Volunteer Expo held as part of the National Volunteers Week on Thursday 22 May, which he attended with Mayor Rossetti, Deputy Mayor Madeley, Councillor Tatterson and Councillor Ripper. The night was very well run, a huge success with lots of people present. Councillor Wells acknowledged and made special mention of several groups of people from across Wellington Shire Council who were involved in the organisation of the night. Councillor Wells also acknowledged the excellent food and catering provided by the Hunting Ground and Big Bears Donuts.

COUNCILLOR STEPHENS attended the second community information session run by ESSO Australia (ExxonMobil) on the de-commissioning of the thirteen rigs across Bass Strait. The “Pioneering Spirit” ship will be brought out in 2027 to dismantle the rigs and CMA Contracting will undertake the job of de-commissioning from 2028 over a 3 - 4 year timeframe. There are plans to employ 60-80 staff onsite with preference to employ local people where possible. The planning permit application process is likely to have begun. It will be good to get local people trained up to work for CMA contracting and then transfer to offshore roles. ExxonMobil will continue to produce gas until approximately 2035.

10. DELEGATES REPORT

COUNCILLOR MADELEY provided an update following her attendance yesterday at the Gippsland Climate Change Network Incorporated (GCCN) meeting. Several exciting developments were discussed across the region. The Gippsland Offshore Wind Community Assembly has officially commenced with 50 randomly selected community members from coastal and nearby areas, now participating in a deliberative process of exploring how offshore wind can best benefit the Gippsland communities, families and coastline. The network has also secured funding from Regional Development Victoria to support further community and energy projects, including updates to the Gippsland new energy portal, youth education programs on renewable careers and coordination of offshore wind information and electrification for local groups.

Plans are also well underway for Gippsland’s new energy conference being held 9 – 10 September 2025 in Traralgon. This event, originally initiated by Wellington Shire, will feature prominent speakers with a research focus and ‘on farm’ sustainability showcase.

COUNCILLOR MADELEY provided an update on the Gippsland Art Gallery Advisory Group, following attendance at last night’s quarterly meeting. The Gallery continues to thrive. Recent updates were received for upcoming and recent exhibitions and public programs, with strong gallery attendance figures, positive media coverage and continued success in philanthropy with some notable donations and acquisitions for the collection. A number of proposed acquisitions were discussed as well as generous donations from private collectors. These editions significantly enrich the Gallery’s collection and reflect the commitment to artistic excellence and cultural growth in the region.

There was a great deal of excitement for the blockbuster exhibition - Turner and Australia, which is the Gippsland Gallery’s major exhibition for the year. This is a journey through two centuries of epic landscape painting, a unique and compelling exhibition that explores the timing of Turner’s major artistic breakthroughs. The exhibition draws together key works by Turner, some of which have been borrowed from Australian public collections and will be represented alongside a diverse chronology of Australian Art. Works include those by Eugene von Guerard, Frederick McCubbin, Tom Roberts and Arthur Streeton. This ticketed exhibition will run from 7 June to 24 August 2025.

COUNCILLOR LOWE attended a meeting held at the Stratford Football Club on Wednesday 28 June on the Stratford Structure Plan. There were around 15 attendees which was a reasonable turnout. Some good issues were raised, some of which included the preference for a school crossing supervisor at the Stratford Primary School; a 40km zone from the Daycare past the Primary School; a path to Stratford Daycare; access across the highway to the Stratford gymnasium; new signs located at each end of Stratford naming the town services; zoning; parking and the future expansion of Stratford including the preference that letters be dispatched in relation to future expansion sites, possible rezoning and options for sub-division. Attendees seemed to 'get a lot out of it'. It was a productive session.

COUNCILLOR BANNERMAN attended the bi monthly meeting for the Star of the South (Southerly Ten) Community Advisory Group and provided an update. The Group encompasses a wide range of community representatives who come together to discuss and challenge issues around the wind turbine development and connection through to the electricity grid. Discussion focused on the Giffard Hub area (the area where the underground cables from the offshore wind turbines are due to hit land and the path through the Loy Yang-Rosedale area). Whilst the initial stage was proposed to be underground, the second stage is proposed to be above ground. All developers, including Southerly Ten, will be required to arrive at the connection point at Giffard. Stage 1 of the Project is moving ahead. The State Government will hold an auction for 2 gigawatts of power with the aim of having this in service by 2033. The longer term aim of the Victorian Government is that through this Giffard onshore area, 7 of the 9 gigawatts will come through this hub by 2040.
