- 2. Extension of funding to the Future of Yarram Project for a further 12 months ending 30th June 2027 to enable the Project to assist the Yarram and District community and workers who have lost their jobs following the closure of the AKD Yarram timber mill.

8. INVITED ADDRESSES, PRESENTATIONS OR ACKNOWLEDGEMENTS

COUNCILLOR BANNERMAN acknowledged Angas Moncur, an outstanding young man who, at 16 years old, came up with the idea to host an event for the benefit of the Australian hay runners, a local charity who organise hay and other supplies for farmers in most need of feed for their animals. Angas put together Victoria's "4WD Show and Shine" event on 22 November 2025 which was held outside Rosedale. It was a hugely successful day, both as an event and for the intended purpose of raising money for the Australian hay runners. Over \$12,000 was raised on the day.

Councillor Bannerman thanked everyone who participated in the day and contributed toward the charity as well as all the volunteers who put in countless hours of volunteer work. A fabulous event.

COUNCILLOR TATTERSON acknowledged on Tuesday 25 November, six Wellington Shire Councillors went to Dargo to visit a number of facilities around Dargo, beginning with the Bush Nursing Centre which holds much importance to the local community and the tourists who visit Dargo followed by the Dargo Museum and Dargo Hall. Councillor Tatterson acknowledged and made special mention of the terrific job undertaken by the volunteers in Dargo and the importance of the volunteers to a town like Dargo which allows the community to thrive and stay busy.

COUNCILLOR TATTERSON as Deputy Chair of SEATS Victoria (South Eastern Australian Transport Strategy) acknowledged the Committee meeting which was held on 20 November 2025 hosted in Leongatha. A couple of key discussion points around transport issues across the network included, for Gippsland, some major projects such as the Traralgon Bypass which has received strong advocacy from SEATS and other key agencies. The Traralgon Bypass is one which SEATS is keen to keep on the agenda and to see the Government start working on the planning for how the bypass can progress, either via the current route or via an altered route. This is an important project as it currently takes a very long time to get product from East Gippsland and Wellington through to the markets in Melbourne. The SEATS session included the Sale alternate truck route; Warragul Drouin transport planning and presentations from the Port of Hastings where the solar and wind alternate energies were outlined, particularly offshore wind and the importance of both the Port of Hastings and Barry Beach.

There was also an opportunity to view some of the revitalisation projects in Leongatha who have done a terrific job linking the rail trail to the former railway in the middle of town and in revitalising this area of town. It was a very productive day and well attended by Councillors across Gippsland and Council staff.

COUNCILLOR RIPPER acknowledged the significant impact and uncertainty that the closure of the Dicky Bill farm business in Maffra has on families, employees and associated businesses. This represents not only the loss of local jobs, but also disruption to livelihoods and broader impacts to the region in the lead-up to Christmas.

Council remains committed to supporting affected workers and engaging with relevant State and Federal government agencies. There will be a support event for affected workers and community hosted by Workforce Australia, Regional Development Victoria and Wellington Shire Council at the Maffra Memorial Hall on 10 December 2025 from 10am to 2pm.

COUNCILLOR STEPHENS acknowledged the 16 Days of Activism campaign against domestic violence (held between 25 November to 10 December 2025) and Yarram Neighbourhood House who held an event last Tuesday with a walk at 4am in the morning. There were over 100 participants and over 500 kilometres was covered during this walk. The event concluded with a barbeque (BBQ) at 6.30am at the memorial gardens supported by the Health Service in which around 40 people attended and a final walking lap. It was a great event for recognising and supporting action against Domestic Violence. Councillor Stephens re-iterated a thank you to Yarram Neighbourhood House and also to Cathy Cook and team for their efforts.

Councillor Stephens also acknowledged the special expo held at Yarram in relation to the closure of the AKD Timbermill, an event supported by the Wellington Shire. This was another great event with around 50 local workers who took part. Present on the day were well over a dozen stall holders, a number of job providers, 'Services Australia' and various Council representatives such as Ashley Smirl and Rachel Weatherly from the Economic Development unit of Wellington Shire Council. Councillor Stephens also acknowledged Sara Rhodes-Ward from Regional Development Victoria (RDV) and Darren Beggs from Workforce Australia who put the whole event together.

Councillor Stephens also acknowledged that today is the 31st birthday of the Wellington Shire Council, to which Councillor Stephens can recall 31 years ago his attendance at the very first meeting when the Commissioners were sworn in on 2 December 1994.

COUNCILLOR MADELEY, following on from Councillor Stephens' acknowledgement about the 16 Days of Activism, reminded everyone that there is a Walk Against Violence happening next Wednesday 10 November 2025 in Sale commencing from 4pm at the Clocktower. The walk will conclude at the Port of Sale for a community BBQ.
