Application to Register a Swimming Pool or Spa

Form 22, Regulation 147P(1), Building Regulations 2018, *Building Act 1993*

For pools or spas constructed prior to 1 November 2020 (147L): Complete this registration form with evidence of construction date and/or pay applicable search fee.

For pools or spas constructed from 1 November 2020 (147M): Complete this registration form and attach a Form 23 Certificate of Barrier Compliance that has been issued within the last 30 days by the relevant building surveyor.

For relocatable pools and spas that have been erected for 3 or more consecutive days (147N): Complete this registration form on the 4th day after the relocatable pool or spa was erected.

Note: Registration of a swimming pool or spa is not complete until the statutory fee has been paid in full.
