Description The stables are a large timber building with red gum frame clad in stained weatherboards. The central section of the building has a vaulted roof containing a clerestory with skillions extending either side. Sets of eight paned windows let light in through the end walls and skylights in the roof provide additional illumination. Inside the building, a set of stables lines each side of the building. The floors are brick paved. Mezzanine storeys, probably originally used for storage, are located above the stables.(1) The early iron truss roofing system is also intact. RNE 000615)

A rare surviving stable building of 1879, originally the livery and letting stables of Cobb & Co with arched roof and side skillions for loose-boxes etc. reminiscent in form of the metropolitan establishments which no longer survive, this example is constructed in timber, with only the arched roof of corrugated iron and wrought iron tie rods. (National Trust Register, B5550)

Condition and Integrity: The building is in good condition having been renovated recently for use as a market. The building has been underpinned and much of the external cladding has been replaced. A large roller door was put into one side by a previous owner. The central section has been repaved recently and fixed seating and lighting installed. (June 1989) (RNE 000615)

The front of the stables is attached to red brick shops fronting Raymond Street. A brick arch connecting the front and rear of the shops announces the entrance to the stables. Further research into the date of construction and purpose of these shops is required to establish their associations with the stables.

Condition & Integrity: The building has been recently converted to a market use and is in good condition. Much of the external cladding has been replaced and a roller door added to one side by a previous owner. The central section has been repaved and new lighting and seating installed.(1) Internally the stables and mezzanine above is intact. The brick shops have altered facades. The parapets and connecting arches are relatively intact. The arch to the rear of the shops has been sand blasted to remove paint and the path to the stables is concrete.

History

The stables were built by Paterson as a Horse Bazaar for Cobb & Co. in 1878.(2) A coach service to Melbourne was started in 1859, Cobb & Co. taking over the Port Albert run in 1862 and the soon after Hewitt's coach service to Melbourne.(3) Sale was the Gippsland headquarters of Cobb & Co. Their first stables were in Foster Street, with later stables being built in Bond Street.(4)
